WASH in HCF Proposed Resolution to be discussed at WHO Executive Board in January 2019

The Kingdom of Eswatini, United Republic of Tanzania and the Republic of Zambia are jointly proposing a draft resolution to the [144th Executive Board](#) on Agenda Item 6.6: Patient Safety. The draft resolution urges Member States to set targets, establish and implement minimum standards and ensure WASH is mainstreamed in health programming. It also calls on the Director General to provide global leadership, report, with UNICEF, on the global status, and support country implementation. The discussions will take place the end of January 2019 at WHO.

JMP Core questions for WASH in health care facilities now published in Arabic, French, Russian and Spanish:

Earlier this year, the JMP published a set of [recommended core indicators](#) to support harmonized monitoring of WASH in HCF in support of the 2030 Agenda. The indicators include definitions for “basic” water, sanitation, hand hygiene, health care waste management and environmental cleaning. Country snapshots



Ghana: A two-day Call to Action on AMR, took place in Accra in November, co-hosted by Wellcome with the governments of Ghana and Thailand and the United Nations Foundation, and organised in partnership with the Inter-Agency Coordination Group (IACG) on Antimicrobial Resistance. WaterAid was identified as one of seven AMR pioneers. At the “Promoting Pioneers” session, innovative examples of work that has been having an impact on AMR around the world were showcased to draw out transferable approaches and tools that could support others. It was widely recognised that a health system approach is necessary rather than focussing on infrastructure alone. Read more [here](#).

Nepal: Terre des hommes SAFA Water Project



The SAFA Water Project aims to strengthen government systems to improve WASH services, with special focus on water quality and sanitation services in 30 HCF and communities in the Bardiya district of Nepal. The project was developed within the national initiative for WASH in HCF, led by the Ministry of Health (MoHP). To provide strategic guidance to the project, a Project steering committee (PSC) has been formed. The genuine involvement of local authorities plays a crucial role in fostering the ownership and sustainability of the project, especially in the new (federal) political context of Nepal. A tripartite MoU has been signed between the municipalities, the implementing partner GERUWA and [Terre des hommes](#) (Tdh), which defines clear roles and responsibilities for project implementation. A workshop was held on 29 Nov to bring the various stakeholders (NGO, local and district authorities, media, civil society) together to launch the project and map activities for the successful implementation of the project. Tdh also collaborates in Bardiya district with WHO and WaterAid to roll out the [WASH FIT digital tool](#).

Tanzania: WaterAid WASH in HCF workshop



WaterAid held a 3-day workshop on WASH in HCF in Dar es Salaam, Tanzania in November. Programme managers, advocacy specialists, and programme managers across 10 WaterAid country programmes and 3 regions came together to build internal capacity by sharing lessons learned, challenges and gaps in WaterAid’s programming. The exploratory workshop provided a space for self-assessment, peer-to-peer collaboration and brainstorming. Participants took a deep dive into topics including gender/equity & inclusion and human rights based approaches, influencing government and policy, WASH and IPC, partnerships and collaboration, assessments, monitoring and indicators, O&M and infrastructure. The workshop provided an opportunity to develop WaterAid’s organisational focus, including their role and niche and identified ways to continue organisational cross-learning. Tanzania: Training of decision and policy makers on WASH in healthcare facilities



In November, UNICEF, in collaboration with Emory University, held a training for policy and decision makers from the water and health sectors from the government of Tanzania, the private sector and NGOs to strengthen their knowledge of water, sanitation and hygiene in relation to quality of care, IPC and AMR; demonstrate the necessity for cross-sectoral work and strong leadership to improve WASH in HCF and chart a way forward to implement the national guidelines and strategy for WASH in healthcare facilities. Close to 30 participants attended the training. A report will be shared in a few weeks time.

Antimicrobial resistance (AMR) updates

AMR, WASH and the Global Conference on Primary Health Care (25-26 Oct 2018)

The recent Global Conference on Primary Health Care provided an opportunity to refocus global attention on primary health care (which is lagging behind in terms of service provision despite global advances in public health) and its links to UHC – including **universal access to WASH** and effective antibiotics. Health leaders reaffirmed their commitment to the historic [1978 Declaration of Alma-Ata](#), and vowed to strengthen their primary health care systems. An expert panel session on “**Antimicrobial Resistance: Unfinished Agenda for Primary Health Care**” was held. World Antibiotics Awareness Week (12-18 November) “Our time with antibiotics is running out”

Global activities included a number of new releases such as results from the European CDC of two point-prevalence surveys of healthcare-associated infections and antimicrobial use in hospitals and in long-term care facilities in the EU/EEA ([news release](#)). WHO produced an [infographic](#) on appropriate use of antibiotics in surgery.

SIDA call for proposals

The Swedish International Development Cooperation Agency (Sida) is supporting the 2019 call for proposals from the Joint Programming Initiative on Antimicrobial Resistance (JPIAMR) with up to SEK 35 million (approx. €3.4m) for researchers from 30 African countries. Researchers in Africa* are invited to form or join transnational teams together with counterparts in Asia, Europe or North America to produce tools, technologies and methods for diagnostics and surveillance of antimicrobial resistance.

*Researchers based in the following African countries will be eligible for support: Benin, Burkina Faso, Burundi, Central African Republic, Chad, Comoros, Congo (Dem. Rep.), Eritrea, Ethiopia, The Gambia, Guinea, Guinea-Bissau, Kenya, Liberia, Madagascar, Malawi, Mali, Mozambique, Niger, Rwanda, Senegal, Sierra Leone, Somalia, South Sudan, Sudan, Tanzania, Togo, Uganda, Zambia, Zimbabwe. This list is based on the World Bank list of low-income countries in Africa and the list of African countries where Sida has bilateral development cooperation.
